The subject is finished by the exam. During the semester the student prepares, presents at the seminar and submits a seminar work. During the exam period, student will take an verbal exam. To obtain an A (excellent), a student must earn at least 95%, evaluation B at 90%, evaluation C at least 80%, evaluation D 75%, E at least 70%. A student who earns less than 65% will be rated by FX. The resulting evaluation is calculated as the average of the evaluation of the seminar work, the written test and the verbal exam.

Course objective:

- to distinguish and describe dogmatic concepts and holy rules;
- to classify and characterize the basic sources of canon law, the secondary source of canon law and its basic collections;
- to explain and give examples of application of akrivia and ikonomia, their principles and ways of application;
- to describe and explain the understanding of ecclesial norms and the principle of interpretation;
- to explain and justify in their own words the relationship of canon law and liberty in the life of the Church;
- to explain the conditions for granting of baptism and chrismation, to justify the position based on the application of the canons.
