Course objective:

After the course the student will be able:

- to characterise situation of history of philosophy in the period after Hegel and Marx;
- to define criticism of historical culture;
- to interpret dialectic of Enlightenment as a history of philosophy;
- to present content of the term reconstruction of history;
- to clarify new outlines of universal history
- to analyse the theme philosophy of history after the end of the philosophy of history (Philosophie der Geschichte nach dem Ende der Geschichtsphilosophie)

Course content:

Analysis of late classic philosophy of history and its basic determinations. Late classic philosophy of history as a discipline of polycentric character and many theories. Questions of adequate philosophical reflection of history and potential new understanding of history. Examination of continuity, factuality, holism, variety, individuality, narrativity, memories with analysis of the shift of the visual angle of philosophical consideration. Crisis of the historical, which comes subsequently after great philosophy of history: Burckhardt's criticism of philosophy of history, Nietzsche's criticism of historical culture. Postphilosophical and historical reconstructions of history. Analysis of subjective forms of presence and presentation of history. Scientific and theoretical and hermeneutic reflections of history- Droysen, Dilthey, their elaboration within examination of forms and basis of historical knowledge- Windelband, Rickert. Reflections on the experience of historical aspect of subject- Gadamer, Heidegger. Universal and historical interpretations to historical aspect- Spengler, Weber, Toynbee, Jaspers. Spectrum of new collusions about validity of historical culture for example also outlines of antihistorical philosophy of history-

W. Benjamin. Positions in the dispute about historism and views of up-to-dateness, or obsolescence of history- Meinecke, Löwith. Simmel.
