on and/or practice in professional translation and interpreting. The study program itself is designed so that its goals of education, its outcomes, content, focus and courses form a coherent, logically anchored and conceptual whole, corresponding to the graduate profile; the graduate profile is systematically structured and created on the basis of long-term monitored and evaluated requirements of practice, experience of teachers lecturing in the programme and also on proposals and consultations with the stakeholders who have participated in the creation of the study programme. Partial goals and outcomes are defined in the course description sheets, in which the given requirements are specified in much more detail. The graduate acquires and further develops their knowledge, skills and competences from the said areas of knowledge, research and further personal and social development.

### The knowledge acquired:

The graduate can recognize, understand and can practically use research methods in translation and interpreting studies, define and design theoretical and methodological aspects of language communication in their research, apply the principles of text interpretation in practice, has mastered and can use their knowledge of the following areas: academic writing in English, legal translation and court interpreting, contrastive linguistics research, comparative literature studies, research methodologies in linguistics, research methodologies in literary studies, methods of translating non-literary texts, methods of translating social science texts, current issues of translation criticism, hermeneutic and phenomenological reading of the text, translational hermeneutics, linguistic issues of translation, linguistic issues of interpreting, translation of a non-literary text, translation of a literary text.

#### Skills acquired:

The graduate can enhance the skills acquired so far in the magister programme: the skills of mastering translator's and interpreter's professional skills in a highly competitive environment of the translation and interpreting industries: he/she can apply strategies and techniques, methods and principles of (non)-literary translation in a specific language pair; he/she can apply the techniques and procedures of conference interpreting in its consecutive and simultaneous form on the Slovak language side, he/she can implement linguistic procedures in the Slovak language as the mother tongue both when translating from the Slovak language and on the translation side when translating into the Slovak language; he/she can actively utilise terminological resources, corpora and databases, he/she can implement various translation management procedures; he/she can utilise CAT-tools; he/she well versed in the field of post-text editing, editing and finishing of translation and translation quality management; he/she can search for and formulate professional topics and tasks, he/she can consider recommendations, propose optimal solutions to and conduct research on theoretical issues and practical aspects related to translation and interpreting studies, as well as related to linguistic and literary topics. The graduate can autonomously design and select adequate procedures and implement them in solving professional issues, including project design. The graduate is ready to conduct research with a high degree of creativity and independence and evaluate its results with the professional use of information and communication technologies.

The graduate can present the acquired skills in selecting the methods of research depending on the issue explored; he/she can further develop and present the mechanism of search, processing and application of adequate research methodologies; he/she can acquire and properly demonstrate knowledge of demanding terminological and work stereotypes in the explored area; he/she can further develop cognitive prerequisites for successful mastering of theoretical concepts and approaches to research; he/she can improve and demonstrate their communication skills; he/she can take a creative approach to solving given issues; he/she can make appropriate, moral and socially responsible decisions.

At the same time, the faculty has developed precise rules for the creation of study programs within which study plans are compiled, and for the creation of individual study plans (Directive on doctoral studies at the Faculty of Arts, University of Prešov in Prešov <a href="https://www.unipo.sk/filozoficka-fakulta/tlaciva-dokumenty/">https://www.unipo.sk/filozoficka-fakulta/tlaciva-dokumenty/</a>).

The student's study plan determines the time, content and sequence of study course and the forms of evaluation of achievement. Based on the study program, the student's recommended study plan is compiled, it contains the time and sequence of study program units and forms of evaluation of achievement and is compiled in such a manner so that by completing it the student meets the requirements for successful completion of doctoral study within the standard length of study. The recommended study plan defines the list of compulsory and optional courses and the recommended range of elective courses, the number of credits and hours of instruction and the recommended terms in which the courses are to be taken.

The individual study plan, which consists of a study and research/publication part, is compiled by the student together with the supervisor, who submits it for approval to the specific field commission. By enrolling, the student determines what part of the obligations prescribed by the study program he/she wants to complete in the next period of study to which the enrolment relates (trimester, term or academic year). The selection of the courses is conditioned on by the number of credits prescribed for the given period so that the student can meet the requirement for admission to the following year of study. The prescribed number of credits required for admission to the following year is given in Art. 30 sec. 9 of the Prešov University Study Regulations (link above). The student shall select the courses in accordance with Decree 614/2002 Coll. on Credit Study, the PU Study Regulations and the Doctoral Studies Directive (links above):

- 1. By enrolling, the student determines what part of the obligations prescribed by the study program he/she wants to complete in the following period of study to which the enrolment relates (trimester, term or academic year).
- 2. The selection of the courses is conditioned on by the number of credits prescribed for the given period so that the student can meet the requirement for admission to the following year of study.
- 3. During the study, the student may re-take a compulsory course that he/she has failed. After the second unsuccessful attempt to complete the compulsory course, the student is expelled from the programme [Sec. 66 Subsec. c) of the Act].
- 4. During the study, the student may retake an elective course that he/she has failed, or enrol in another elective course instead. After the second unsuccessful attempt to complete the selected elective course, the student is expelled from the programme [Sec. 66 Subsec. 1 letter c) of the Act].
- 5. During the study, the student may re-take an optional course that he/she has failed, or enrol in another optional course or an elective course from the elective courses not yet completed. If the student has achieved a sufficient number of credits, he/she does not have to enrol in any other elective course. If the student has not achieved a sufficient number of credits, after the second unsuccessful attempt to complete the selected elective course, he/she is expelled from the programme [Sec. 66 Subsec. 1 letter c) of the Act]. The study plan is an integral part of the study program.

When creating Study programmes, the parties involved include guarantors and boards of all interested faculties, and/or part of the university as well as several chairpersons of the respective-field-based secondary schools and their respective representatives. These stakeholders decide by their joint proposal on the submitted proposal, the documented information or the application for authorization to run the Study programme. The recommended study plan is given as a separate appendix. Within the elective courses, the student can specialize in the field of translation and interpreting (non/literary, court translations, etc.).

#### - further requirements to be met by the student:

In order to successfully complete the programme within the study credit system, it is necessary for the student to complete all the compulsory courses and obtain a sufficient number of credits in the prescribed structure, successfully pass the state exams prescribed by the study program and defend the doctoral dissertation. The individual study plan of the doctoral student consists of study and research/publication modules. The study module is completed by a dissertation exam, including the defence of a pilot study. The research/publication module is completed by the defence of the doctoral dissertation.

In the minimum number of credits (240), the minimum requirements for courses of the study program must be met. The prescribed credit structure is set out in point e).

#### - requirements for the state examination:

The doctoral student shall register for the dissertation examination if he/she has been awarded the credits in accordance with the accredited study program and if he/she has submitted a pilot study. The doctoral student shall complete the dissertation examination no later than by the end of the penultimate year of the standard length of study. The date of the dissertation examination is determined by the Dean/Rector following a proposal by the chairperson of the research field commission. The retake or substitute date of the dissertation examination shall be established no later than one semester before the proper completion of the standard length of study. The dissertation examination consists of a discussion on the pilot study and colloquium in which the doctoral student is expected to demonstrate his/her theoretical knowledge in the area determined by the accredited study program. The dissertation examination shall take place in front of a commission comprising at least four members, at least one them is not a member of faculty at which the doctoral student studies. The decision by the examination commission on the results of the state examination shall be made at a non-public session of the examination commission.

The doctoral student may apply for permission to defend the dissertation to the Dean/Rector if he/she has successfully passed the dissertation examination and has been awarded the required number of credits for the entire study of the relevant study program in the structure given for the accredited study program (excluding the number of credits to be awarded for doctoral dissertation defence). An application for permission to defend the dissertation may be submitted by the doctoral student even after the end of the standard length of study, so that he/she may meet all the requirements for the proper completion of the study within two years of its completion.

As a dissertation, the doctoral student may also submit his/her own published work or a collection of his/her own papers, the content of which is related to the topic of the doctoral dissertation. The Dean/Rector shall appoint the chairperson of the commission for the doctoral the dissertation defence, further members and opponents without undue delay after the opinion of the study field commission and the proposal of the said commission for the members of the commission have been submitted. Opponents cannot be members of the commission; however, they have a right to vote on the result of the dissertation defence. PU study regulations in Art. 38 (link above) stipulates the circumstances of the procedures leading to awarding the academic title, including the members of the commission and opponents, date, the minimum number of members in the commission, etc.

# - rules for retaking courses:

The rules for retakes apply to both courses (specified according to the degree obligation) and exams (specified according to exams in specific courses and state exams).

During the study, the student must re-take a compulsory course that he/she has failed. With regard to an elective course taken but not completed, it can be re-taken during the study; instead of the same course a different elective course from the group, in which the failed compulsory elective was taken, may be selected. With regard to a failed elective course, a different elective course may be selected. If a student has achieved a sufficient number of credits by completing compulsory and elective courses, he/she will not have to enrol in any other elective course.

In the academic year in which the course is taken, the student has the right to two exam re-takes. At the student's request, the examiner may allow a re-taking an exam even if the student has successfully passed the exam on the regular exam date.

A doctoral student who fails the dissertation examination (awarded FX) may re-take the examination only once. Only the course in which the doctoral student was awarded FX on the first date, is re-taken. After another failure, the doctoral student is expelled from the study.

Re-take of the dissertation defence is stipulated in Art. 38/16 of the PU Study Regulations. A doctoral student who, on the basis of the result of the dissertation defence or for his/her unjustified absence in the defence session, was proposed not to be awarded an academic degree by the dissertation defence commission, may re-apply for permission in the same study program, however, no earlier than six months after the date on which he/she was expected to defend his/her dissertation. The defence of the doctoral dissertation can be re-taken only once, meaning it shall take place no later than two years after the end of the standard length of study. Pursuant to No. 39/2, if the Dean/Rector decides that the procedure according to the regulations was not followed during the defence proceedings, he/she shall request a re-take of the defence.

# - rules for extension, interruption of studies:

Extension of the study is possible, however, pursuant to Art. 24 Sec. 2 of the PU Study regulations, study in a program may not exceed its standard length by more than two years. The student may interrupt his/her study in accordance with Art. 40 of the Study Regulations. The Dean shall give permission for the study to be interrupted. The student may request for interrupting his/her study in writing, specifically:

(a) for a maximum of two years on the grounds of health issues only once at each stage of the study;

b) for a maximum of one year without giving a reason, only once at each stage of the study.

Pregnant students may request the interruption of study for six weeks before the expected date of giving birth, but no later than the date of birth. The period of interruption due to giving birth (maternity leave)/having a baby (parental leave) is suggested by the student herself/himself. However, this period may not exceed three years.

The application for the interruption of study may be submitted before the beginning of the academic year after proving the fulfilment of obligations for the previous academic year, or at the beginning of the spring term after proving the fulfilment of obligations for the previous term of the relevant academic year. Based on serious, especially health issues, the Dean/Rector may give permission for interrupting the study even if the above conditions are not met. The study shall be interrupted until 31st January or 31st August of the respective year. Study interruption period shall not count towards the standard length of study and shall be recorded in the MAIS system.

- e) For individual study plans, the institution states the requirements for completing the individual parts of the study programme and the student's progress within the study programme in the given structure:
  - number of credits for compulsory courses required for proper completion of study/completion of part of study: 80 credits study part 30 credits; courses included in the state exam: pilot study for the dissertation exam 20 credits, current theoretical and methodological aspects of translation and interpreting studies 5 credits, doctoral dissertation defence 30 credits and one of the following fields: linguistic issues of translation, linguistic issues of interpretating, issues of non-literary translation, issues of literary translation 5 credits
  - number of credits for elective courses required for proper completion of study/completion of part of study: a min. of 10 credits For courses in research/publication activities in the translation and interpreting studies, the student must obtain a min. of 105 credits, with a min. of 70 credits being represented by publishing activity.
  - number of credits for elective courses required for proper completion of study/completion of part of study: a min. of 2, a max. of 12

Pursuant to the PU Study Regulations (Article 13), the student shall select elective courses so that the sum of the number of credits awarded represents a max. of 5% of the total number of credits (max. 4 credits in the second stage of study), the achievement of which is a requirement for proper completion of study. Completed elective courses, and/or recognized and exceeding 5% are not included in the number of credits required for proper completion of study. All completed courses are listed in the Diploma Supplement.

- number of credits for the doctoral thesis and defence of the doctoral dissertation required for the proper completion of the study: 30 credits
- number of credits for professional practice required for proper completion of study/completion of part of study: 15 credits
- the courses taken during a study or research stay at a foreign institution (15 credits) are considered elective courses
- number of credits required for proper completion of study/completion of a part of study for project work with the indication of relevant courses in engineering study programs: the present programme is not an engineering study program
- number of credits required for the proper completion of study/completion of part of the study for artistic performances, except for the final work in art-based study programs: the present programme has not been designed in such a manner.

# f) The institution describes the rules for verification of learning outcomes, students' assessment and the possibilities of appealing against the assessment.

Verification of study outcomes and evaluation of students is carried out in accordance with the PU Study Regulations (Article 16), which sets out the assessment scale and success criteria for classification levels. The course description sheets contain information pertaining to the knowledge, skills and competences that students will acquire in completing the course, as well as the requirements for successful completion of the course, the method of assessment and course completion.

The course teacher shall register the assessment in the MAIS no later than three weekdays following the exam date. The assessment is archived in the printed reports generated at the end of the exam period and stored in the department of academic issues. The student shall check the correctness of the registered results no later than three weekdays after the end of the respective term and, in case of detected discrepancies, he/she shall contact the course teacher (PU Study Regulations, Art. 16, point 13).

Regarding the students with special needs, the Faculty of Arts staff shall opt for adequate forms and methods of teaching as well as the assessment and proceed in accordance with the recommendations of the <u>Metodického sprievodcu študentov so špecifickými potrebami/</u> Methodological Guide for Students with Special Needs.

If the student so requests, the Vice-Dean/Vice-Rector for Academic Affairs may, in justified cases, allow an examination to be taken on a specially assigned date before a commission appointed by the Dean/Rector. The student may apply for such a specific exam date and form at the department of academic issues no later than five week-days after the regular date or the first re-take date (PU Study Regulations, Art. 16, item 21). The student may request corrective procedures also on the grounds as specified in the Act on Complaints 9/2010 Coll. or PU Disciplinary Code Code <a href="https://www.unipo.sk/public/media/14733/5">https://www.unipo.sk/public/media/14733/5</a> disciplinarny poriadok.pdf and the University of Prešov Study Regulations <a href="https://www.unipo.sk/public/media/14733/stud\_por2018.pdf">https://www.unipo.sk/public/media/14733/stud\_por2018.pdf</a>.

# g) Conditions for recognizing the study/part of study.

The rules for running the study program regulate and enable the recognition of the study and/or part of study in accordance with the Convention on the Recognition of Qualifications concerning Higher Education in the European Region so as to promote national and international student mobility. At the University of Prešov in Prešov, full recognition of the learning outcomes obtained at the host institution is guaranteed in accordance with the "Learning Agreement" which the student submits before leaving for another university. The rules for the recognition of study, part of study, individual courses and credits are formulated in Art. 15, Sec. 5 and Art. 20, Sec. 1 -10 of the PU Study Regulations. A faculty student has the right to complete part of his/her study at another university in the Slovak Republic or abroad. Consent for the study and for its duration is granted by the Dean/Rector, or Vice-Rector for External Relations and Marketing based on the type of mobility, and this is a matter of a tripartite agreement between the student, the sending faculty and the host faculty. Upon return, the faculty will recognize part of the study in accordance with the contract, the European standard and the European Credit Transfer System. If a student has completed part of his/her study at a university that has not implemented a compatible credit system, the recognition of credits shall be performed by the guarantor of the study program and the credits shall be awarded by the faculty ECTS coordinator. The course can be recognized with a content agreement amounting to 60% with the course of the current study programme. Recognition of state exam subjects is not possible. The number of credits can be recognized within the range of the numbers of credits as specified in the current study program.

On the basis of the Learning Agreement and the Transcript of records, the ECTS coordinator shall register the results in the MAIS system. ÚVV RPU shall issue a Certificate of Participation in Mobility to the student who submitted the documentation to ÚVV RPU. ÚVV RPU shall report to the faculty authorized person the information about the exact dates of the student mobility. The authorized staff member shall register the information about the completion of the mobility in the MAIS.

### opportunities and procedures for participation in student mobility,

In the Erasmus + Charter (ECHE) for the new programming period of 2021 – 2027, the PU has recently committed itself to adhere to the principles of recognizing study at partner foreign universities. The processes of recognizion of foreign mobilities have been the subject to an independent EC evaluation and are the subject to regular monitoring by the National Agency for the Erasmus + Program (SAAIC). The university and the faculty support the participation in student mobility as an opportunity for the student to actively shape their own professional profile in addition to meeting the requirements arising from the study plan. # 8. Spatial, material, and technical provision of the study programme and support

a) List and characteristics of the study programme classrooms and their technical equipment with the assignment to learning outcomes and courses (laboratories, design and art studios, studios, workshops, interpreting booths, clinics, priest seminaries, science and technology parks, technology incubators, school enterprises, practice centers, training schools, classroom-training facilities, sports halls, swimming pools, sports grounds).

The University of Prešov provides educational and research activities in the premises in its ownership, as well as in the leased premises. The Faculty of Arts of the University of Prešov, as one of the biggest faculties of the university, is located in the main campus of the university campus at Ul. Novembra No. 17. Prešov also housing laboratories and centres of excellence for research.

The staff of the Institute of Translation and Interpreting Studies, as a structural unit of the Faculty of Arts, PU, conduct lectures and seminar sessions, conduct research using the facilities in the Linguistics, Translation and Interpreting Centre of Excellence, which is assigned to the Institute of Translation and Interpreting. Equipment for professional translator and interpreter training, including a conference and lecture room (No. 91) utilised for the training of conference interpreting, contains interpreter booths with sophisticated interpreting software and electronic equipment, an additional classroom intended for practicing strategies and techniques of consecutive and simultaneous interpreting (No. 170) with full technical and software equipment provided within the implementation of the following projects financed from the EU structural funds: Linguistic and Translation and Interpreting Center of Excellence (ITMS project code: 26220120026; implementation: 05/2009 - 04/2011) and Refurbishing and extension of the Linguistics and Translation and Interpreting Centre of Excellence (ITMS project code: 26220120044; implementation: 02/2010 - 01/2013). At the Institute of Translation and Interpreting several lecture and seminar rooms with full WIFI coverage are available, along with data projectors (with presentation boards and relevant technical equipment), computer and software equipment (classrooms: No. 180, 188, and 75). A reference library is attended by students and teachers, containing relevant and current publications in the field of translation studies, linguistics, interpreting studies, literary science, translation criticism, pragmatics, professional terminology, etc.

Classrooms and lecture rooms equipped with PC and software enable the arrangement of optimal timetable for all students as well as favourable conditions for consultancy and research of staff and doctoral students. The technical support, located in each lecture room, enables the use of the Internet and presentation technology during all lectures and seminars. The use of electronic lexicographic manuals, the Slovak National Corpus or speech signal analysis programmes have become a common part of teaching, based on use of and search for resources by students. Internet access enables the use of electronic teaching materials (by which teachers streamline students' access to study materials in the Moodle) (https://elearning.unipo.sk/), on the institute's website (https: // www.unipo.sk/filozoficka-fakulta/instituty-fakulty//ipat-new/) also on teachers' professional websites.

Students can use the library resources at the institutes, which run double-honour degree translation and interpreting study programmes. As part of projects related to the construction of the Center of Excellence, a cutting-edge Language Laboratory with top-notch software was established at the Faculty of Arts, enabling high quality interpretation courses. In addition, students have access to specialized classrooms with equipped with interpretation booths that are identical to the facilities used by the EU institutions in Brussels. What is more, since 2010 the Language and Culture journal/Jazyk a kultúra was established as part of LPTCE activities, an electronic journal of the Linguistics and Translation and Interpreting Center of Excellence at the Faculty of Arts of the University of Prešov with open-access content and free access (https://www.ff.unipo.sk/ jak /). The Language and Culture journal is a double-blind-peer-reviewed academic journal publishing original research papers and articles in various fields, esp. in philology, linguistics, translation studies, literary science, mass media studies and children's speech research. It publishes reviews of books and publishing news from the given fields, as well as announcements on scholarly events. It is indexed in the EBSCO, ERIH Plus, Brill, CEEOL, Google Scholar, Library.ru (RSCI) databases and will apply for indexing in the SCOPUS database. It is also a quality forum for peer-reviewed publications by doctoral students.

# b) Characteristics of the study programme information management (access to study literature according to Course information sheets, access to information databases and other information sources, information technologies, etc.).

The data regarding the study programme is available through the MAIS academic electronic system (Modular Academic Information System). MAIS has been designed mainly for the processing and registration of the admission procedure, registration of study issues,

theses and doctoral dissertations, study programs and recommended study plans; as well as timetables. Contacts and information are available at: https://www.unipo.sk/cvtpu/hlavne-sekcie/MAIS/kontakt/, e-mail: sprava-mais@unipo.sk.

Access to study literature, information databases and other information sources is provided to students mainly by the University Library (https://www.pulib.sk/web/kniznica/strana/nazov/informacne-zdroje). University library also provides consultancy, copying and bibliographic registration of theses, operates the Digital Library (https://www.pulib.sk/web/kniznica/strana/nazov/elektronicke-dokumenty), organization of exhibitions of scientific literature, exhibitions of works of art, concerts, presentations, professional library events and openings, etc.

Library services are used by more than 8,000 users and university staff. The library offers more than 300,000 publications, and annually subscribes to more than 300 professional foreign and national periodicals, which in total represent more than 9,000 volumes of periodicals. Since 1999, the University Library has been using the ALEPH 500 automated library system to provide better services acquired through the KOLIN grant project (Košice Library and Information Network), funded by the Mellon Foundation (USA). The implementation of this system moved the library to a new, qualitatively higher level reflected in the efficiency of service. The library provides its users with loans and information service. In addition, in recent years the focus has been on bibliographic information services aimed at creating or mediating search from internal electronic information sources and external database centers.

Since 2004, the library has been building the Digital Library, a database of electronic full-text publications by university staff, the digital library contains more than 800 publications. There are 303 study places available in 6 study rooms (of which 2 are equipped with databases). The library has its own computer network (PULIBnet) with 4 servers, 84 computers, of which 45 computers are available for library visitors. Every year, the library publishes a bibliography of PU publications. The library provides access to 9 funded full-text database centers (EBSCO, Gale, ProQuest, Science Direct, Scopus, Springer, Taylor and Francis, Web of Knowledge, Wiley). Access to them is achieved by logging in through the library account: https://www.pulib.sk/web/kniznica/strana/nazov/informacne-zdroje

The library is a part of the nationwide project NISPEZ (National Information System for Support of Research and Development in Slovakia – Access to Electronic Information Resources) covered by CVTI SR Bratislava. Thanks to the project, the visitors were provided with online access to the following 7 database centers: Wiley Online Library, Knovel, ProQuest Central, Science Direct, Scopus, Springer, Taylor and Francis, Web of Knowledge. There has been a long-standing interest in the Scopus and Web of Science citation databases, as well as in the ProQuest and EBSCO Academic Search Ultimate bibliographic databases, which PU has provided from its own resources for the second year in a row. Trial access to other databases and various trainings, webinars, and/or database presentations are also available. Since these databases are accessible only to university staff and students from university computers, for better use, PU users are also allowed access from home computers via the EzProxy service – remote access to external electronic resources. The library has streamlined citation processing since 2020 also thanks to the citation manager CitacePro, which can significantly facilitate access to the citations from individual sources according to various applicable standards. The library cooperates with the central registers of the Slovak Republic – the Central Register of Publishing (CREPČ) and the Central Register of Artistic Activities (CREUČ).

All offices and all classrooms are connected to the university network, and special software is available for teaching and researching (statistical software, e-learning systems, internet media, resources to enable people with disabilities to participate in the proper teaching process). PU has leased a multi-license of the statistical software Statistica. All teachers, students and the university staff are authorized users of the license. As part of projects from the EU SF, a system for automated test processing was purchased in 2011 for all PU faculties. The students also have free internet access on the campus and dorms.

# c) Characteristics and extent of distance education applied in the study programme with the assignment to courses. Access, manuals of e-learning portals. Procedures for the transition from contact teaching to distance learning.

The Institute of Translation and Interpreting Studies providing the study program runs the programme in such a manner so that the students can study autonomously. Several means are used to make the courses available, especially through the Microsoft Teams platform, the new central LMS system EKP purchased within the EU SF grant schemes. Basic information about the e-learning tools and technical support is provided by CVT PU (https://www.unipo.sk/cvtpu/hlavne-sekcie/sluzby/elearning/).

In order to support online education, the Institute also utilises the Moodle platform available at https://elearning.unipo.sk/, accessible to all students and faculty at the University of Prešov. If any technical problems occur, it is possible to contact the LMS administrator, Mgr. Ladislav Palko (ladislav.palko@unipo.sk).

All PU staff and students use the Office 365 package, which includes the Microsoft Teams platform with "classroom" functionality, by means of which study groups and team classrooms can be formed, it is possible to store study materials in one's own cloud and make them available to students, it is possible to deliver lectures, seminars, exercises and real-time consultations, make audio-visual recordings, give exams (with the results and written feedback from the course teacher). Technical support to students and teachers is provided by CVT PU, Ing. Radko Modranský (radko.modransky@unipo.sk). Testing tools of both platforms, LMS Moodle and Office 365 Forms, are used to assess the achieved results of distance learning.

The procedure for the transition from full-time to distance education is governed by the Rector's Measures, published at https://www.unipo.sk/aktuality/. Information on the implementation of distance learning, procedures, manuals and video instructions for the use of e-learning tools is available at: https://www.unipo.sk/vzdelavanie/dist/.

E-courses are intended as a support for full-time courses, providing all students with commented on audio-visual lectures in, along with their ppt /x. a pdf. format, further teaching materials, seminar assignments, students' work, joint group and individual projects.

# d) Institutional partners in providing educational activities for the study programme and the characteristics of their participation.

A doctoral student in the Translation and Interpreting studies programme is a mature, cognitively, morally, ethically and socially fully fledged personality who, through his/her work and research ambitions and their fulfilment, individually contributes not only to his/her further growth, but is also beneficial for the society as a whole. Within the study programme, he/she can choose from elective and optional courses, which define his/her current and future professional and pedagogical functioning. The choice of elective courses takes into account the preparation for the future teaching and lecturing (PhD student's teaching (4 classes per week throughout a semester)), at the Institute of Translation and Interpreting at FF PU, or at the respective language institute. A doctoral student can also acquire teaching experience and internships abroad on the basis of Faculty agreements on cooperation with foreign universities (more than 80% of cooperation agreement no-time-limit based (faculty agreements: https://www.unipo.sk/468). Graduates of 2nd cycle can complete their internship with a long-term partner – Lexika Translation Agency, Miletičova 21, 821 09 Bratislava, contact person: Eva Dinušová, vendor manager. During the internship, the students work under the supervision of experienced translators and interpreters and gain experience in translation and interpreting work, as well as in the coordination of translation/interpreting projects. They can also use this cooperation later, in practice, during their doctoral studies.

The Translation and Interpreting Agency affiliated to the Linguistics and Translation and Interpreting Center of Excellence represents a functional platform and organizational unit of the Institute of Translation and Interpreting Studies for acquiring and maintaining partnerships in achieving real-life experience of the translation and interpreting market. This platform, also affiliated to the Institute of

Translation and Interpreting Studies, is commissioned for translation and interpreting tasks, thus providing the services to the entire University in all language specializations taught at the Faculty. In addition, the Agency provides services to the to external clients. The main goals of its functioning are: 1) to provide quality translation and interpreting services, thus contributing to the enhancement of translation culture in Slovakia as well as to general awareness of the specificity and complexity of the professions of translator and interpreter and 2) to provide translation students with contact with real-life translation practice and interpreting, thus preparing them for entering the labour market after completing their university studies and, finally, 3) to provide doctoral students with experience in supervising novice translators and interpreters in fulfilling their tasks. The Agency has a long-term cooperation in providing these services with the Regional Gallery in Prešov, the said cooperation was formalized on the basis of a long-term cooperation agreement.

#### e) Characteristics of the possibilities for social, sports, cultural, spiritual and social activities.

Doctoral students enrolled in Translation and Interpreting Studies programme can engage in sports activities, enjoy cultural and social relaxation offered by the city of Prešov and its surroundings, by the University and Faculty, as well as by the Institutes and Departments of the Faculty/University.

University students have can enjoy sports activities in PU sports facilities, such as a swimming pool, gym, multi-purpose sports complex and multifunctional playground. There are 11 art ensembles at the University of Prešov, which are members of the Council for Art Activities of the University. The members of the ensembles are mostly university students.

University Dr. Štefan Hések Pastoral Centre (hereinafter UPC, http://upc.unipo.sk/) is a part of the nationwide network of university pastoral centres. Its main task is to address the university students' and teachers' spiritual needs of. UPC uses a chapel in the dorm in UI. November 17, a TV room in the dorm in Exnárova 36 and hall no. 100 at the Faculty of Humanities and Natural Sciences. The Greek Catholic Youth Pastoral Center (GMPC, www.gmpc.grkatpo.sk), founded by the Archbishop's Office in Prešov, also engages in spiritual activities at the PU and cooperates very intensively with Greek Theological Faculty offering various leisure activities.

In their leisure time the doctoral students may engage in the activities linked to the programme they are enrolled in:

- contribute and editorially cooperate with the Journal of the Academic Community of the University of Prešov in Prešov NA PULZE (http://napulze.unipo.sk/tiraz),
- contribute to the open access online peer-reviewed scholarly journal entitled Language and Culture, the publishing of which is supervised by the Linguistics and Translation and Interpreting Center of Excellence at the Faculty of Arts of the University of Prešov.
- Participate in student institute and faculty scientific conferences and publish in proceedings in the Digital Library FF PU (select http://www.pulib.sk/web/kniznica/elpub/dokument/Slancova1, http://www.pulib.sk/ web / library / elpub / document / Slancova2, http://www.pulib.sk/web/kniznica/elpub/dokument/Olostiak15);
- work in the University media (Mediálka Television, UNIPO Press, Radio PaF);
- $\bullet \ participate \ in \ A cademic \ Pre\'sov, \ the \ competition \ of \ artistic \ creativity \ of \ university \ students \ in \ Slovakia.$

Accommodation is provided to students in four separate facilities: Dormitory – Ul. November 17 no. 11; Dormitory – Ul. November 17 no. 13; Dormitory - Námestie Mládeže no. 2; Dormitory – Exnárova no. 36) and 2 special facilities (Orthodox Priestly Seminary; Greek Catholic Priestly Seminary).

The dorms offer independent study rooms and private rooms, they cater for the cultural, social, sports activities and hobby activities of the students. The dormitory managements cooperate with the Student Boarding Council, the Student Police Service and Radio PaF, the manager of PU dormitories participates in discussions and informs students about the activities and operation of the PU dormitories.

# f) Possibilities and conditions for participation of the study programme students in mobilities and internships (indicating contact details), application instructions, rules for recognition of this education.

Erasmus + mobility: the conditions for the student mobility are as follows:

- The applicant is a citizen of the Slovak Republic, or a country of the European Union, or other countries participating in the ERASMUS
- + Program
- The applicant is a student (enrolled in a given academic year) of a higher education institution in the Slovak Republic to which the Erasmus Charter (ECHE) has been awarded, or is a citizen of another country, a full-time bachelor, magister or doctoral student (enrolled in a given academic year) in a higher education institution in the Slovak Republic to which the Erasmus Charter (ECHE) has been awarded.
- A grant can only be awarded to a student who has completed the 1st year of university study. However, a student can apply for a mobility in his/her 1st year.

Erasmus + mobility: procedure for applying for student mobility:

- Each academic year, the Department of External Relations and Marketing (Foreign Relations) at the PU publishes information on the student mobilities within the signed interinstitutional bilateral agreements on the websites of the university, faculties and workplaces.
- According to the valid rules for the EU programming period 2021 2027, the mobility can last a min. of 3 and a max. of 12 months. The total length of an Erasmus + mobility per student can reach 12 months at each stage of study.
- After submitting the application for the mobility (with the attached Statement of study results and possibly also a motivation letter), the student takes a test or participates in an oral interview.
- At the receiving institution, the student is obliged to choose the courses so that he/she can obtain a min. of 15 credits, while the selection of courses and possible alternatives will be personally discussed with the IPT Erasmus + coordinator (Associate Prof. Mgr. Ingrida Vaňková, PhD.). The institute coordinator assesses the compliance or the similarity of courses selected by a student at the partner institution with the field of study and the study plan at the Faculty of Arts. If there is no agreement and the coordinator does not approve the similarity of courses, the selected courses will not be recognized as compulsory or elective (A and B block of courses in the respective study program), the given courses will be only recognized as optional courses (C block of courses in the study program).
- The student together with the coordinator prepares the so-called Proposal for recognition of the content of study and courses completed within the mobility, on the basis of which he/she will fill in the Learning Agreement. It indicates the courses of the PWD and gives a list of courses selected by the student at the partner university. The study contract specifies which courses will be recognized as compulsory, elective or optional. The condition for recognition of the course is it being signed by the authorised Credit Transfer Agreement (i.e., Credit Transfer Agreements have to be submitted and signed for each course to be attended at a host university), it is agreed and signed by the institute coordinator (vice-dean). If a completed course is recognised as an alternative to a compulsory or elective course, the Credit Transfer Agreement must also be signed by the teacher conducting the course at the home institution.
- If a student chooses a subject that the Faculty offers in the following year(s) of study in the given study program, after assessing the compliance with its content, the course will be recognized (i.e., the student will not be obliged to complete it in the following year(s) of study).

- If the host university does not offer an alternative course to the one listed in the given study program at the Faculty, the student completes it at his/her home institution enrolling in it in the next year. It is mandatory to contact each teacher in person before leaving for mobility and to agree on the conditions for a course completion.
- If during the mobility there is a change in the selected courses listed in the original Agreement, the student will immediately contact the Institute Coordinator and agree on the changes (Changes to Learning Agreement for Studies form), re-introducing the new courses in the Agreement credit transfer.
- Upon returning from the mobility, the student shall contact the faculty ECTS coordinator no later than 5 week-days, submits a copy of the Study Agreement (including changes) and a copy of the Transcript of Records. The faculty ECTS coordinator shall register the grades (including course codes and titles), and assigns them to the student's study plan in the MAIS system.

  Erasmus + internships / Practical internship: objectives and conditions
- The aim of the mobility is to help students adapt to the requirements of the European labour market, gain research and professional skills and work experience.
- Any PU student (a citizen of the Slovak Republic or another country) duly enrolled in the given year for the entire study in a full-time or part-time program for bachelor, magister or doctoral cycle may apply for the internship. A graduate internship is intended for graduating students.
- Applicants who have previously experienced Erasmus + mobility can also apply for a grant.
- The total length of mobilities (study, internship) must not exceed 12 months in one cycle of study.
- The host institution must meet the eligibility requirement: the organization is involved in economic activity in the public or private sector, regardless of its size, legal form, the economic sector in which it operates, including the social sphere of the economy.
- Host institutions can be: (1) businesses, large and small; (2) public and private organizations, including social enterprises; (3) public / state-run institutions at local, regional or national level; (4) higher education institutions to which ECHE (Erasmus Charter) has been awarded, research centres; (5) non-profit institutions; (6) foundations/funds; (7) associations, (8) schools/educational centres at various levels (from pre-school facilities kindergartens, through primary and secondary schools, including adult education); (9) social partners, including chambers of commerce; (10) craft/professional associations and trade unions; (11) career guidance institutions; (12) training centres; (13) national diplomatic missions (embassies, consular posts, etc.)
- The completed internship abroad will be fully recognized by the student using ECTS credits.

# 9. Required abilities and admission requirements for the study programme applicants

#### a) Required abilities and necessary admission requirements.

The doctoral study program (hereinafter referred to as "doctoral program") as a third-cycle study program focuses on the acquisition of knowledge based on the current state of art of research and knowledge and especially on the student's own contribution to it, which results from conducting research. Postgraduates obtain a third-cycle university education. The present doctoral programme is carried out within Translation and Interpreting Studies, pursuant to Sec. 54 of Act no. 131/2002 Coll. on Higher Education Institutions and on Further Amendments to Certain Acts, as subsequently amended (hereinafter referred to as the "Act"), and is governed by the Study Regulations of the University of Prešov. The standard length of study for the full-time doctoral study programmes is four years, in the part-time form it is five years. The requirements for admission to the Translation and Interpreting studies doctoral programme is the completion of a magister degree in philology or a related field (as defined in the description of this field of study) and a successful passing of the entrance examination. The general requirements of the admission procedure are determined by the Study Regulations of the PU in Prešov. Specific requirements presuppose in-depth knowledge of the theory, history and critique of translation, comparative studies and interpretation in translation, methodology and technical interpreting, within broader theoretical contexts. The knowledge fundamentally exceeds the level of the state examination at the magister degree and the master examination and relates to translation theory, history and criticism, non-literary translation and terminology, literary translation derived to types and genres, comparative literature, contrastive language research, comparative versology, methodology and history of literary science. The above-listed issues are related to the potential topic of the dissertation.

#### a) Admission procedures.

Admission procedures, basic and further conditions for admission to study are governed by Sec. 54 and Sec. 57 of Act no. 131/2002 Coll. on Higher Education Institutions and on Amendments to Certain Acts and are explicitly formulated in the Study Regulations (Articles 3 – 8), available at: https://www.unipo.sk/public/media/14733/stud\_por2018.pdf.pdf. The study regulations stipulate the method of publishing the conditions of admission to study, the rules of the admission procedure, the requirements concerning the decision on admission to study and the possibilities of reviewing the decision. On the website of the Faculty, in the Study options section: https://www.unipo.sk/filozoficka-fakulta/moznosti-studia/, the conditions of admission, the list of double-honour degree programmes, general information about the admission procedure and special information on selected programmes are published for applicants. The Principles of the Admission Procedure of the Faculty of Arts of the University of Prešov are accessible to applicants. The admission procedure is reliable, fair and transparent. The criteria and requirements for candidates are published in advance and they are easily accessible. The conditions of the admission procedure are inclusive and guarantee give opportunities to every applicant who fulfils the criteria.

During the entrance exam, the applicants will present the project of the intended dissertation. The admission procedure takes the form of a discussion in the course of which the candidate is expected to prove the ability of analytical, critical and creative thinking in the area related to the selected topic of the doctoral dissertation. In addition, aesthetic feeling and critical thinking of the candidate are assessed if he/she is interested in the issue of literary translation. Part of the exam is a presentation of previous research related to the topic of the intended dissertation.

Preference is given to the candidates who have been publishing in the field.

The scope of knowledge and topics to be manifested by candidates:

- basic characteristics of theoretical works on translation studies based on the Slovak School of Translation A. Popovič, J. Ferenčík, J. Vilikovský, B. Hečko;
- a project: atranslated text and its interpretation;
- prompt stylization of issues in the mother tongue;
- command of one (1) foreign language,
- successful defence of the dissertation project.

The candidate takes also takes the entrance exam in a foreign language. Command of a foreign language at level B2 is required. The candidate chooses one foreign language from the menu of four world languages (English, German, Russian, and French).

In summary, the entrance exam includes: a) presentation of a research project proposal related to the topic of the dissertation, which the candidate has chosen from the listed topics; b) assessment of general prerequisites (completed study programme, mastery of prescribed areas, previous achievements of the candidate in research, previous theses and publications, etc.).

#### 10. Feedback on the quality of provided education

### a) Procedures for monitoring and evaluating students' opinions on the study programme quality.

In accordance with the Higher Education Act, the students are encouraged to express their opinion on the courses attended and the course teachers, as well as their opinion on the conditions of study in anonymous questionnaires. The Faculty of Arts of the PU continuously strives and implements activities aimed at involving students in the process of self-evaluation and evaluation of content of study programs, and in the evaluation of support services, technologies, research, cultural, sports and other extracurricular activities. The evaluation process incorporates the results of the evaluation on the basis of two types of surveys with a focus: Evaluation of study programmes in MAIS (general survey) and Evaluation of courses in MAIS (course survey). The evaluation of programmes is also carried out from the teachers' perspective, the suitability of the structure of courses, the categorization of courses within the Suggested Study Plan is re-evaluated. The received feedback is communicated to the Faculty management and subsequently analysed and reflected on. The department/institute running the study programme provides feedback on the quality of the teaching after the end of each term. Each teacher evaluates his/her feedback and informs his/her superior (director of the institute) about it. Based on the feedback data, measures are then taken to improve the quality of teaching. The department/institute also evaluates the study programme by its graduates. Evaluations follow a precise schedule at least twice an academic year, always after the end of the term through the modular academic information system MAIS.

Teachers of language-oriented institutes also use their own tools in order to obtain feedback – surveys and questionnaires, focused on a comprehensive evaluation of institute activities, evaluation of content and scope, pedagogical, practical and personal competences of teachers. The Institute of Translation and Interpreting studies has always used its own questionnaires, approaches there students with individual requirements and possible issues during, and has group and individual discussions with students.

#### b) Results of student feedback and related measures to improve the study programme quality.

After concluding the MAIS Course Evaluation (course survey), its results are available to teachers and department heads/institute chairs. The results of "The evaluation of study programmes" is accessible to the department heads /institute chairs, who can use it in order to improve the quality of the programmes. Suggestions obtained from surveys, questionnaires, interviews with students are continuously summarized, assessed by the teachers and department heads/institute chairs, consulted with relevant staff (Director of the Institute, Dean's Board of Advisors, Board of Education, Rector's Board of Advisors) and subsequently the aspects of the study programme are reconsidered. The measures taken in order to increase the quality of the study programme include, seminar session/lecture observations, state final examination observations, adding senior staff to MS Teams groups, submission and checking of online attendance sheets or checking of video recordings and study materials published. In this way, it is possible to monitor and evaluate the course of teaching in part-time study. The results of the student feedback are included in the annual reports submitted to the Scholarly Councils and the Academic Senate, which also includes the students. Subsequently, the outcomes are published on the faculties and university websites. The reports thus are the basis for finding ways to improve the study programme. Positive evaluations within the obtained feedback relate mainly to the teachers' high professionalism and expertise, proactive approach to students, linking content of teaching with practice. Any comments on the teaching are then communicated to the institute staff and proposed solutions to improve teaching are given.

The system of evaluation of the quality of the education by students is regulated by the following documents: Internal system of evaluation of the quality of education at the PU and Rector's Measure no. 8/2021 Involvement of students in the internal quality system.

# c) Results of graduate feedback and related measures to improve the study programme quality.

The Institute of Translation and Interpreting studies is highly proactive in obtaining feedback on the study and the degree and form of employability of (post)graduates, which is reflected in the register of successful postgraduate students, retained contacts with them and a developed feedback system from this target group of respondents, structured and semi-structured interviews as well as personal meetings. The obtained results are incorporated into the SWOT analysis carried out within the Institute's Activity Report and

subsequently translated into specific proposals and measures to increase the quality of the teaching and other activities of the Institute. The intention of the Institute of Translation and Interpreting studies is to create an alumni association in the near future.

Postgraduate feedback is provided through a survey taken by the Rector's Office of the University of Prešov. The postgraduate feedback is not used by many students, so the results cannot always be considered reliable. Another way of obtaining feedback from the students is the Faculty of Arts Alumni Club https://alumni.ff.unipo.sk/, which serves as a communication channel between the Faculty of Arts and its graduates, the aim of which is to integrate graduates into the life of the faculty and get their feedback.

The postgraduates of the study programme are involved in creating the present study programme, they are regularly approached, they provide valuable feedback, comments and suggestions in the current process of commenting on and assessing the present study programme.
