Continuous evaluation: During the semester, the student chooses a topic within the course, which is elaborated and presented in a seminar exercise. By the end of the semester, the student will submit a seminar paper on the selected topic.

Final evaluation: The course is completed with a verbal examination. The final assessment considers the student's response to questions during the verbal examination (70%), the assessment of the presentation of the selected topic in the seminar exercise (10%) and the text of the seminar paper (20%).

### **Learning outcomes:**

Students will gain knowledge of the main theories of international relations (ToIR), which will enable them to scientifically interpret the historical development of international relations, to better understand the current issues of contemporary international relations and to make informed estimates of their future development. ToIR are an essential part of a political science education, complementing the theoretical knowledge that students acquire from other courses included in the political science curriculum that focus primarily on issues related to the processes (and institutions) of domestic politics. In the course, students will be introduced to the origins and ideological sources of ToIR, basic scholarly approaches to interpreting the subject and nature of international relations, and the scholarly discourse on the methods of international relations research. The course includes the application of ToIR to selected current issues in contemporary international relations

### Course content:

The origins and institutional development of ToIR, historical types of international relations systems as the subject of ToIR reflection (classical Greece, Roman world, Middle Ages, Westphalian system), precursors and ideological sources of ToIR (political philosophy, history, international law), theoretical dispute about the nature of international relations and the object of research (liberal-idealist versus realist interpretations of IR), dispute about the method of research on IR (traditional approaches to research on IR versus scientism), peace research after World War II (traditional and critical directions, its influence on the formation of neoliberalist and neorealist interpretations of the International Relations), integration theories (functionalism, neofunctionalism, federalism, transactional analysis), analysis of international regimes (systems analysis, game-model analysis, functional analysis, normative-institutional analysis, problem-structural analysis, cognitive analysis), system-theoretical

models of international relations according to M. A. Kaplan (balance of power system, loose bipolar system, rigid bipolar system, universal system, hierarchical system, veto system), application of game theory in international relations research (zero-sum game, cooperative game, coward's game, prisoner's dilemma), critical theories (marxism, postmodernism, constructivism, feminist studies, green political theory), Copenhagen School securitization theory (the process and sectors of securitization).

Final evaluation: The course is completed with assessed credit. The final evaluation takes into account the assessment of the presentation of the selected topic in the seminar (30 %) and the text of the seminar paper (70 %).

# **Learning outcomes:**

Students will gain knowledge of the development of domestic and foreign policy of selected post-Soviet countries (primarily Russia and Ukraine) starting from the collapse of the Soviet Union to the present day. They will gain an understanding of the development of political systems of these countries in comparison with other former communist countries of the Eastern bloc, including the main actors in the politics of selected post-Soviet countries. At the same time, students will gain knowledge about foreign and security policy of the selected countries, including attempts to reintegrate the former USSR space (Commonwealth of Independent States, Eurasian Economic Union, other integration projects), conflicts between the former USSR republics, including frozen conflicts on their territory, their relations with the EU and NATO, including the evolution of their relations with the Slovak Republic. Special attention within the course is paid to the causes, course, and impact of the Russian-Ukrainian crisis since 2014 on the European security and interests of the Slovak Republic.

## Conditions for passing the course:

The condition for completing the course is active participation in seminars (completion of the course).

During the semester, the student is obliged to process partial tasks - scientifically correct formulation of the problem, research goal, set hypotheses, design and construct a research method (questionnaire, observation sheet, test, survey), prepare a presentation related to the thesis, which indicates the basic theoretical starting points, goal and methodological procedure of processing the research problem.

At the end of the semester, the student submits a working version of the thesis to the supervisor, which will contain all the essentials of the thesis.

The student will receive 40 points (minimum number of points for completing the course - 20) for active participation in seminars, submission of a report on completed consultations and processing of partial tasks.

To complete the course, the student is required to obtain at least 50 points.

Credits are awarded by the supervisor of the diploma thesis.
