| Assessment and completion of the course: Final exam Conditions for passing the course: The course ends with an oral exam, for which the student can obtain a maximum of 60 points. The student can obtain a maximum of 20 points for the interpretation of the specified topic in a time of 20 minutes, for which the student will also prepare a presentation. In addition, the student can obtain a maximum of 20 points for active and regular participation in seminar classes (participation in discussion and interpretation of seminar texts). Two absences are tolerated. The third unjustified non-participation means extra work for the student after an agreement with the teacher. More than three absences mean for the student FX in the given subject. To obtain an A rating (excellent) he must obtain at least 90%, to obtain an B rating at least 80%, to obtain a C rating at least 70%, to obtain a D rating at least 60%, to obtain an E rating at least 50%. A student who obtains less than 50% will be graded FX. The final evaluation is calculated as a summary of the evaluation of the oral exam, interpretation and active participation in the seminar classes. | |

| Course content: 1) The position of Slovaks in the Austro-Hungarian monarchy at the end of the 19th century, confrontation with the ideology and politics of Hungarianism - the human-clerical current, nationalists, voters, ideology and politics; 2) Slovakia in the 1st Czechoslovak Republic - political, economic and cultural realities; 3) Consequences of Munich's policy for Czechoslovakia, declaration of Slovak autonomy 4) Introduction of the political monopoly of Hlinka's Slovak People's Party, declaration of an independent Slovak state on March 14, 1939 (a by-product of Hitler's aggression in Central Europe), Slovak National Socialism, Jewish Code - genocide of the Jewish population. | |
