8. Spatial, material and technical provision of the study program and support

- a) List and characteristics of study program and their technical equipment with assignment to educational outputs and subjects (laboratories, design and art studios, studios, workshops, interpreting booths, clinics, priestly seminars, science and technology parks, technology incubators, school enterprises, practice centers, training schools, classroom-training facilities, sports halls, swimming pools, sports grounds) The Faculty of Education of the University of Prešov in Prešov is located in a unified building of the former Primary School on UI. November 17, for which an extension in the form of teaching spaces was completed. The original part of the building has undergone the necessary reconstruction and there are rooms for teachers, doctoral students and administrative staff. Because the faculty has been providing blended education through Moodle software for decades, the electronization of educational activities, including e-knowledge of students and faculty staff, is at an above-standard level - with properly equipped teaching rooms, lecture halls as well as offices. In total, it is at the faculty: • 154 personal computers,
 - 134 personal computers,
 105 lantons and AlO devices
 - 105 laptops and AlO devices,

- 25 scanners,
- 47 printers,
- 30 data projectors,
- 6 interactive whiteboards,
- 19 screens,
- 2 modern visualizers,
- 3 cameras and 4 camcorders, which are, however, gradually being replaced by mobile devices capable of recording images and sound of appropriate quality.

The faculty also has purchased software Statistica, Adobe InDesign, as well as the universitywide office suite Office 365, which integrates Word, Excel, Powerpoint, e-mail client, as well as cloud storage (and others) into one system.

Of the total number of 19 classrooms, each is equipped with a personal computer and a projector with a projection screen, in two rooms there is also a visualizer. Thanks to their easy portability, these devices can be moved as needed. In two computer rooms there are 24 and 12 personal computers designed for students' work. Most computers are equipped with a webcam. In the two primary lecture halls there is also a modern videoconferencing system capable of monitoring the movement of the teacher, including professional sound technology with portable wireless ports, wireless handheld microphones, as well as static microphones, designed for sound in both the departmental part of the room and the student. Due to the existence of the Department of Music, art and physical education, the faculty also has electronic keyboard devices designed for teaching music education, as well as 5 pieces of classical pianos. For the needs of art education, an art studio was set up with painting stands, sinks and equipment compatible with the needs of this study program.

For the needs of students in connection with pandemic measures during full-time teaching, the faculty is working on a project to install modern co-working tables in the corridors of rooms, which will allow better diversification of students, as well as the possibility of storing a laptop and connecting it to the electrical network.

b) Characteristics of information provision of the study program (access to study literature according to information sheets of subjects), access to information databases and other information sources, information technologies, etc.)

The University Library of the University of Prešov (UK PU) plays a key role in the information security of the study program. UK PU is a scientific-information, bibliographic, coordination and advisory department of the university, which provides library and information services primarily to students and staff of the university and, within its capabilities, to the other professional public. The library provides the following basic and special library and information information services:

- Lending services: absenteeism, full-time, interlibrary loan service and international interlibrary loan service.
- Bibliographic information services: creation, resp. mediation of searches from internal information sources and from external domestic and foreign database centers with regard to the profiling of PU.
- Consulting services: lectures focused on the use of primary and secondary library apparatus; methodological assistance in the use of funds, catalogs, services and others.
- Reprographic services: these services are provided exclusively from the information sources of the UK PU, in accordance with the provisions of copyright law.
- Other services: processing of records of publishing activities of university employees; operation of the Digital Library of the Charles University in Prague; digitization of musical works from our own collection and their access in the multimedia and

database study room, realization of exhibitions of professional literature, openings of works of art, concerts, presentations, professional library events, etc.

The UK PU library fund contains a total of almost 225,000 library units. Since 2004, the library has been building the Digital Library (a database of electronic full-text publications created by university staff, which contains more than 800 publications. Since 1997, it has been building a database of PU publishing activities in which it registers more than 66,000 documents. There are 303 study places available in 6 study rooms (2 of which are databases), more than 70,000 readers visit the library every year and more than 500,000 readers on the library's website. The library has its own computer network (PULIBnet) with 4 servers, 84 The library provides access to 9 paid full-text database centers (EBSCO, Gale, ProQuest,

The Faculty of Education uses e-learning in the doctoral study program (<u>https://moodle.pf.unipo.sk/</u>) as a support for full-time teaching, the program is given priority in person. Moodle tools and tools are an integral part of the study, especially in self-study and testing students' knowledge.

We create comprehensive support for our users in the technical and pedagogical field of elearning. The system is managed by two administrators: prof. Ing. Jana Burgerová, PhD., Who is also its guarantor, and Mgr. Vladimir Piskura, PhD. In the field of technical IT support, we cooperate with the company RokIT Partner sro On the front page of Moodle there are publicly available text files with instructions for working in the system.

It takes place on the basis of friendship, conversations, discussions, invited lectures, spiritual and leisure activities.

Sports activities

Possibilities and conditions of participation

Students who want to take part in a study stay at a foreign university within the Erasmus + program must meet the following student mobility criteria:

- Students of all levels of university study (Bc., Mgr., PhD.) Can take part in the mobility.
- The student must be duly enrolled to study at the University of Prešov in the full-time form of study.
- The grant can only be awarded to a student who has completed the 1st year of university studies.
- Mobility can take min. 3 and max. 12 months.
- The student can participate in Erasmus + mobility (study stay + internship) for a total of 12 months at each level of study.

Instructions for registering a student for mobility

Mobility procedure for study:

- The student will obtain basic information on the website of the faculty in the current call and the procedure of submitting applications for the next academic year (https://www.unipo.sk/pedagogicka-fakulta/vonkajsie-vztahy/erasmus/).
- The faculty coordinator will give an educational lecture for students about the possibilities of studying abroad not only in the period before the application deadline, but also at the beginning of the academic year.
- The applicant will contact the faculty coordinator. The Erasmus Faculty Coordinator will provide the student with more detailed information about study abroad opportunities, partner institutions, etc.
- The student submits an online mobility application (published at<u>https://www.unipo.sk/zahranicie/erasmus/studium/vyzva/</u>) together with the mandatory documentation at the External Relations Department of the PU Rectorate (ÚVV RPU, UI. 17. novembra 15, 1st floor).
- The Vice-Dean for External Relations, in cooperation with the Faculty Erasmus Coordinator, sets and publishes the date for the selection of students for mobility on the Faculty's website. The student arrives at the designated place and attends the interview. If the language of study abroad will be Slovak, the interview will be conducted in Slovak, in other cases the interview will be conducted in the language of study. Applicants are informed of the selection results on the faculty's website (in accordance with the GDPR).
- The successful mobility applicant contacts the faculty Erasmus Coordinator and consults with him on his choice of subjects at the host institution. The student prepares with the Erasmus coordinator a Learning Agreement for Studies and with each teacher the method of recognition of subjects at the home institution in the Credit Transfer Agreement: 1. If the subject is the same at the receiving and home institution the subject is entered into the MAIS with the receiving code institutions and fully recognized.
 If the subject is partially identical in content credit recognized). 3. If the subject of the receiving institution does not exist at the home faculty and is not related in terms of content the subject is recognized as an elective subject (the student hands over the Credit Transfer Agreements to the faculty ECTS coordinator before leaving for mobility).

- The faculty coordinator will give an educational lecture for students about the possibilities of studying abroad not only in the period before the application deadline, but also at the beginning of the academic year.
- The applicant will contact the faculty coordinator. The Erasmus Faculty Coordinator will provide the student with more detailed information about the possibilities of an internship abroad.
- The student finds a suitable company, institution and addresses it. In the case of consent to the possible implementation of the internship, he / she will request an Acceptance Letter from the host institution.
- The department coordinator will sign the Acceptance Letter, thus accepting the company / institution and the scope of work as corresponding to the profile of the internship applicant.
- The Vice-Dean for External Relations, in cooperation with the Faculty Erasmus Coordinator, sets and publishes the date for the selection of students for the internship on the Faculty's website. The student arrives at the designated place and attends the interview. If the language of study abroad will be Slovak, the interview will be conducted in Slovak, in other cases the interview will be conducted in the language of study. Applicants will be informed of the selection results on the faculty's website (in accordance with the GDPR).
- The successful trainee contactes the faculty Erasmus Coordinator and consults with his / her Learning Agreement. for Traineeship) at the receiving institution. The student will electronically send the Internship Agreement by e-mail to the company / institution for completion and approval. The student with the Erasmus Coordinator will prepare a Credit Transfer Agreement, which stipulates how the internship (not the graduate internship) will be recognized: exists) and fully recognized as an alternative. 2. If the subject is partially identical in content, the recognition of the internship and its credit statement

will be agreed (usually recognized as an Erasmus internship, code: abbreviation of the workplace / EROS / year of introduction of the subject).

Rules for the recognition of education

Mobility procedure for study:

- Upon return from the mobility, the student immediately contacts the faculty ECTS coordinator and hands him a copy of the Study Agreement and the Transcript of Records.
- Based on the Study Agreement and the Transcript of Records, the ECTS Coordinator will ensure the recording of the results in the MAIS system.
- The ÚVV RPU will issue a Certificate of Participation in Mobility to the student who submitted the documentation to the External Relations Department at the PU Rectorate (ÚVV RPU).
- ÚVV RPU will report to the authorized person at the faculty information about the exact date of student mobility.
- An authorized employee at the faculty will record information about the termination of mobility in the MAIS.

Procedure for student and graduate internships:

- Upon return from the internship (not the graduate), the student immediately contacts the faculty ECTS coordinator and hands him a copy of the Europass-Mobility document and a copy of the Internship Agreement.
- On the basis of Europass Mobility, the faculty ECTS coordinator will ensure the recording of the internship (not the graduate) in the MAIS system.
