Regarding the scientific and research focus of the staff, individuals and entire teams participate in various research projects, and the outputs of these projects form a major part of their publishing activities.

## Definition of the field of the habilitation and inauguration procedure

Habilitation and inauguration proceedings in the field of Systematic Philosophy are assigned to the field of study Philosophy, which is carried out at all three levels of study. The content of the field of the habilitation and inauguration proceedings is fully compatible with the field of study Philosophy. The field of study Philosophy includes systematic knowledge of a theoretical nature in its base, which reflects issues of philosophical logic, ontology, epistemology, methodology of the sciences, as well as knowledge of a practical or applied nature, which relates to the field of ethics, aesthetics, theory of art, and political and social philosophy. In addition to knowledge of a systematic nature, the field of study Philosophy includes knowledge of the history of philosophy, the history of ethics and the history of aesthetics. All the above-mentioned knowledge is developed through intellectual skills that cultivate critical thinking and analytical abilities.
