Criteria for evaluating the fulfilment of the conditions for obtaining the scientific-pedagogical or artistic-pedagogical titles Associate Professor and Professor

In accordance with § 12 sec. 1 letter d) of Act No. 131/2002 Coll. on Higher Education Institutions and on Amendments and Supplements to Certain Acts (hereinafter referred to as "Act"), in accordance with Decree of the Ministry of Education, Science, Research and Sport of the Slovak Republic No. 246/2019 Coll. on the procedure for obtaining scientific-pedagogical titles or artistic-pedagogical titles of Associate Professor and Professor (hereinafter referred to as the "Decree") in accordance with the Rules of Procedure of the Scientific Council of the University of Presov (UP), after prior discussion in the scientific councils of the faculties of the University of Presov, the Scientific Council of the University of Presov approved at its meeting on 7th June 2022 the following criteria for evaluating the fulfilment of the conditions for obtaining the scientific-pedagogical title "Associate Professor" (hereinafter referred to as the "criteria for the title Associate Professor") and the criteria for evaluating the fulfilment of the conditions for obtaining the scientific-pedagogical title "Professor" (hereinafter referred to as the "criteria for the title Associate Professor") and the criteria for evaluating the fulfilment of the conditions for obtaining the scientific-pedagogical title "Professor" (hereinafter referred to as the "criteria for the title Associate Professor") and the criteria for evaluating the fulfilment of the conditions for obtaining the scientific-pedagogical title "Professor" (hereinafter referred to as the "criteria for the title of Professor").

Art. 1 Criteria for the title of Associate Professor

- 1. The candidate fulfils the basic qualification and has completed the third degree of higher education.
- 2. The candidate has been scientifically and pedagogically or artistically and pedagogically active in the given field of study or a related field of study at the university for a period of at least three years since obtaining the third degree higher education in which the title of Associate Professor is to be conferred on him/her. This includes, in particular, lecturing in selected chapters, thesis supervision, the supervision of seminars and tutorials, or the corresponding forms of teaching. Only the period during which the candidate has been employed by the university, at least part-time, for at least half of the stated weekly working time (including abroad), is taken into account for the performance of teaching activities.
- 3. The candidate proves that he/she has created a complete scientific work in the given field of study with his/her scientific papers or has created a complete work of art in the given field of study with his/her artistic papers and artistic performances. The candidate shall also demonstrate that he or she is a recognised scholar in professional circles or a recognised artist in artistic circles at home and abroad in the field of study concerned. The candidate shall demonstrate that he or she fulfils at least the specific criteria in the field of study in which he or she is applying for the title of Associate Professor. The specific requirements for the fulfilment of these criteria for each research area, field of study and parts of the university are set out in Annexes 1 to 9.

Art. 2 Criteria for the title of Professor

1. The candidate fulfils the basic qualification and is the holder of the title of Associate Professor obtained on the basis of elaboration and defence of the habilitation thesis and successful

completion of the habilitation procedure.

- 2. The candidate has been scientifically and pedagogically or artistically and pedagogically active in the given field of study or a related field of study at the university for a period of at least three years since obtaining the title of Associate Professor in the subjects in the field in which the title of Professor is to be conferred. Only the period during which the candidate has been employed by the university, at least part-time, for at least half of the stated weekly working time (including abroad), has given lectures, seminars and tutorials, and has supervised PhD. students, is taken into account for the performance of teaching activities.
- 3. The candidate demonstrates the publishing of at least one university textbook or two textbooks or teaching texts.
- 4. The candidate demonstrates the successful training of at least two PhD. students in the given or related field of study and the training of at least one PhD. student in the given or related field of study.
- 5. The candidate demonstrates that he/she is a recognised scholar or artist in his/her field of study and that his/her scholarly work or artistic work has achieved wide international recognition. The candidate shall demonstrate that he or she fulfils at least the specific criteria in the relevant field of study in which he or she is applying for the title of Professor. The specific requirements for meeting these criteria for each field of research, field of study and parts of the university are set out in Annexes 1 to 9. In addition, the candidate shall demonstrate international recognition by supportive written statements from at least three professors or other leading international experts from at least three countries, at least two of which shall be from experts from a country other than the Czech Republic.

Art. 3 Common provisions

- 1. The candidates for the title of Associate Professor or Professor shall submit an application containing the requisites according to the Decree and according to the UP Principles on the procedure for obtaining the titles of Associate Professor and Professor, which shall be determined by a measure of the UP rector.
- 2. In the habilitation procedure, the fulfilment of the criteria and other conditions shall be examined by the habilitation committee. It shall state its conclusion as to whether or not the criteria have been met in a written proposal which it shall submit to the chair of the faculty's Scientific Board.
- 3. In the inauguration procedure, fulfilment of the criteria and other conditions shall be examined by the nominating committee. It shall state its conclusion as to whether or not the criteria have been met in a written proposal which it shall submit to the chair of the faculty's scientific council.
- 4. Self-citations and semi-self-citations are excluded when proving citations.
- 5. In the case of candidates from abroad, papers published and citations published in the candidates' country of origin are considered as domestic publications and domestic citations. Experts from abroad are not considered to be experts from their country of origin.
- 6. Fulfilment of the minimum criteria listed above cannot be substituted by fulfilment of the other criteria.
- 7. The fulfilment of these criteria does not entitle to successful completion of the habilitation and inauguration procedure for Professor.

Art. 4 Transitional and final provisions

- 1. The criteria for the evaluation of the fulfilment of the conditions for obtaining the scientificpedagogical titles or the artistic-pedagogical titles of Associate Professor and Professor at the University of Presov enter into force upon approval by the Scientific Council of the University of Presov on 7th June 2022.
- 2. Proceedings for the awarding of the titles of Associate Professor and Professor that were initiated before the entry into force of these criteria shall be completed in accordance with the existing regulations and criteria.
- 3. The Criteria for the evaluation of the fulfilment of the conditions for obtaining the scientificpedagogical titles or the artistic-pedagogical titles of Associate Professor and Professor at the University of Presov of 10th March 2020 are cancelled.
