## **1 PURPOSE**

The purpose of this directive is to monitor and continuously improve the quality of science, research, development, and innovation, to further improve the quality of the implementation of study programmes in the relevant fields of study and the quality of habilitation and inauguration proceedings in the relevant fields of habilitation and inauguration proceedings. This Rector's directive describes the processes for the regular evaluation of IQS creative activities. The Rector's directive is issued in accordance with the Standards for the Internal Quality System, the Standards for the Study Programme and the Standards for the Habilitation Proceedings and the Proceedings for the Appointment of Professors published by SAAHE, which define a set of requirements for the assessment of creative activity.

## 2 AREA OF APPLICATION

This directive is part of the Internal Quality Assurance System of Higher Education at the University of Presov according to Section 15 of Act No. 131/2002 Coll. on Higher Education and on Amendments and Supplements to Certain Acts, as later introduced. The directive is binding for all creative staff of the University of Presov, employed on the stipulated - weekly working time.

## 4 ACCOUNTABILITY AND COOPERATION

The following are responsible for managing this process: the Vice-Rector for Science, Arts, Sport and Accreditation, the Deans of the faculties, and the relevant Vice-Deans of the faculties. The individual implementers of the process and sub-processes are listed in the description of the process and sub-processes.

## **5 DESCRIPTION**

## **5.1 Process information**

- 5.1.1 Directive Regular evaluation of creative activities of IQS is based on generally binding regulations, which are Act No. 269/2018 Coll. on Quality Assurance of Higher Education and on Amendments and Supplements, Act No. 343/2015 Coll. on Public Procurement and on Amendments and Supplements to Certain Acts, as later amended, Decree of the Ministry of Education, Science, Research and Sport of the Slovak Republic No. 397/2020 Coll. on the Central Register of Publication Activity and the Central Register of Artistic Activity, Standards for the Internal Quality Assurance System, Standards for the Study Programme, Standards for the Habilitation and Inauguration Proceedings and Methodology for the Evaluation of Standards issued by the Slovak Accreditation Agency for Higher Education. The provisions of the Rector's Directive No. 1/2021 Basic Principles of Assurance and Evaluation of the Internal Quality System of the University of Presov were also applied in the development of the directive.
- 5.1.2 The University evaluates the IQS of the creative activity of university teachers and

researchers in the scope of:

- a) permanent improvement of the quality of university education and scientific, research, development, innovative or other creative activities,
- b) continuous monitoring, evaluation, and the approval of study programmes,
- c) continuous monitoring and periodic evaluation of habilitation and inauguration procedures in accordance with a specific internal regulation<sup>1</sup>.

# 5.2 Evaluation of IQS creative activities in the context of continuous quality improvement of university education and scientific, research, development, innovation, or other creative activities

- 5.2.1 Each faculty/department has developed a detailed system for evaluating the creative activities of creative employees, which takes the form of their regular annual complex evaluation.
- 5.2.2 Complex performance appraisals of creative employees are intended to provide an overall account of the performance of their essential duties as set out in their contract of employment and job descriptions. The evaluation shall cover creative activities consisting of research activities, teaching activities, grant activities and other supporting activities that are related to the post in which the person being evaluated is employed. The evaluation shall be carried out in phases consisting of a self-assessment of the creative person, followed by a supervisor's assessment and an overall assessment for the department, the University unit, and the University as a whole.
- 5.2.3 Individual performed and evaluated activities of the creative employee consider, in particular, the publication activity and responses, grant activity, teaching activities, supervision of doctoral students by approved supervisors, membership in boards, review proceedings, organization of scientific, specialized, artistic, and educational events, other criteria and attributes according to the particulars of individual faculties or departments.
- 5.2.4 The creative employee shall regularly submit a summary of his/her creative activities to the Head of Department on an annual basis. The creative employee is obliged to regularly update each year his/her Research/Art/Teacher Profile (RATP) and the characteristics of submitted Outputs of Creative Activity (OCA), which are published on the University's website.
- 5.2.5 The results of the creative activity of a creative employee for a given calendar year are evaluated at the level of the Head of the relevant department, the results of the departments belonging to the given faculty are evaluated at the level of the Dean's Collegium, and the results of all faculties and university-wide departments are evaluated at the level of the Rector's Collegium. This evaluation may also serve as a basis for those responsible for the implementation, development, and quality assurance of the study programme for a given or related study programme or field of habilitation and inauguration as a means for evaluating the quality and level of a given programme or field of study.
- 5.2.6 The complex evaluation of the work performance and the results of the creative activity of the creative employee for a given calendar year shall have an impact on his/her remuneration and career promotion.

# **5.3** Evaluation of IQS creative activities in the framework of the continuous monitoring, evaluation and approval of study programmes and the continuous monitoring and periodic evaluation of habilitation and inauguration procedures

Persons who have responsibility for the implementation, development and quality assurance of the study programme, teachers who deliver the profile subjects of the study programme and persons who have responsibility for the development and quality assurance of the field of habilitation and inauguration proceedings shall demonstrate the results of their creative activity by means of the most significant outputs in the given or related field of study in which the study programme or the habilitation and inauguration proceedings are conducted. The level of the outputs is defined as follows:<sup>2</sup>

- a) excellent international level (A+), for habilitation and inauguration proceedings;
- b) at least significant international level (A), if it is a third-degree study programme separately for each study programme<sup>3</sup> according to the Methodology for the Assessment of Creative Activities, which is set out in Part V. of the Methodology for the Evaluation of Standards;
- c) at least internationally recognized level (A-), if it is a second-degree study programme or a study programme combining a first and a second degree separately for each study programme<sup>4</sup> according to the Methodology for the Assessment of Creative Activities which is set out in Part V. of the Methodology for the Evaluation of Standards;
- d) at least nationally recognized level (B), if it is a first-degree study programme separately for each study programme<sup>5</sup> according to the Methodology for the Assessment of Creative Activities set out in Part V. of the Methodology for the Evaluation of Standards.

The recommended categorization of outputs for individual degrees and individual fields of study, to which the fields of habilitation and inauguration are also assigned, is set out in Annex 1 of this directive.

- 5.3.2 Persons who have responsibility for the implementation, development and quality assurance of the study programme, teachers who provide profile subjects of the study programme, and persons who have responsibility for the development and quality assurance of habilitation and inauguration proceedings shall submit a report to the Head of the Faculty Quality Board by the end of February of the year following the evaluation period on the fulfilment of the requirements for the quality of the outputs of creative activities in accordance with the Standards of the Slovak Accreditation Agency for Higher Education.
- 5.3.3 The evaluation of the standards' compliance at university level is guided by a set of indicative measures. In particular, the following indicators shall be evaluated when assessing creative activity in relation to the delivery of education at individual levels and fields of study, or when assessing the fulfilment of the standards for habilitation and inauguration proceedings:<sup>6</sup>
  - a) the number of publications of teachers in the last 6 years in each field of study and category of outputs;
  - b) the number of publications of teachers that are registered in the Web of Science or Scopus databases in the last 6 years in each field of study and category of output (or equivalent, e.g. in the arts);
  - c) the number of publications of doctoral students registered in the Web of Science or Scopus databases over the last 6 years in each field of study and category of output (or equivalent, e.g. in the arts);

- d) the number of responses to the teachers' publications in the last 6 years;
- e) the number of responses to teachers' publications registered in the Web of Science and Scopus databases in the last 6 years;
- f) the number of outputs of creative activity of international excellence, according to the standards of the field;
- g) evaluation of the level of creative activity of the university's unit;
- h) the amount of financial support received from domestic and international grant schemes and from other competitive sources in the field of the discipline;
- i) the number of third-degree study (PhD) students per supervisor (average and maximum number;
- j) the number of third-degree study (PhD) students in the relevant field of habilitation and inauguration;
- k) the number of supervisors in the field of habilitation and inauguration (both natural persons and FTE29);
- I) the number of proposals for the award of the title of Professor approved by the Scientific Board of the University in the current year;
- m) the number of proposals for the award of the title of Associate Professor approved by the Scientific Board in the current year;
- n) the number of habilitation and inauguration proceedings discontinued (proceedings initiated but not approved by the Scientific Board, withdrawn by the candidate, or otherwise discontinued) in the current year.
- 5.3.4 Faculty Quality Boards, according to their evaluation systems, discuss a report on the creative activity of faculties and other units, which they submit to the Rector, together with a proposal for measures to remedy the deficiencies. The Rector shall arrange for the reports to be discussed by the UP Scientific Board and the Internal Quality System Board. The Faculty Quality Boards shall follow the methodology for the evaluation of standards issued by SAAHE.

#### 5.4 Criteria and procedures for assessing the level of output of creative activities

- 5.4.1 As part of the assessment of the level of quality of outputs of creative activity, the originality, rigorousness, and impact of the effect of each output shall be assessed, considering the particularities of the creative activity and their assessment in the relevant field.
- 5.4.2 Originality is understood as the extent to which the output makes a significant contribution to understanding and knowledge in the relevant field. Outputs demonstrate originality in particular by:
  - a) generating and interpreting new empirical findings and/or new material;
  - b) addressing a novel and/or complex research problem;
  - c) developing innovative research methods, methodologies and/or analytical techniques;
  - d) highlighting inventive and creative possibilities for solutions;
  - e) providing new arguments and/or new forms of expression, formal innovations, interpretations and information;
  - f) gathering new types of data with which they operate and/or developing theoretical insights or analyses of doctrine, policy or practice and new forms of discourse.
- 5.4.3 Rigorousness is understood as the degree to which the output demonstrates intellectual coherence and integrity and adopts robust and appropriate concepts, analyses, resources, theories and/or methodologies.
- 5.4.4 The impact of the effect of an output is understood as the beneficial effect of the output on the external environment as well as on its educational activities and students, thus on society, culture, public policy and services, health, the environment, or quality of life in different geographical settings along a local-global continuum. Impact can also mean

the reduction or prevention of risk, harm, cost, or other negative effects.

- 5.4.5 In assessing outputs, assessors holistically consider evidence of the quality of the output in terms of its originality, rigorousness and impact and apply the following general definitions of quality levels, denoted by letters A+, A, A-, B a C:
  - a) **A**+: excellent international level in terms of originality, rigorousness and impact of the output of the creative activity the output brings a new agenda within the relevant creative activity or has a major contribution to the development of the relevant creative activity in a global context;
  - b) A: significant international level in terms of originality, rigorousness and impact of the creative output the output makes a significant contribution to the development of the relevant creative activity in a broader international context;
  - c) A-: internationally recognized level in terms of originality, rigorousness and impact of the output of the creative activity the output represents a substantial contribution to the development of the relevant creative activity in an international context;
  - d) **B**: nationally recognized level in terms of originality, rigorousness and impact of the output of the creative activity the output represents a substantial contribution to the development of the relevant creative activity in a national context;
  - e) **C**: a level below the standard of nationally recognized quality in terms of originality, rigorousness, and impact of the output of the creative activity, or an unclassified output.<sup>7</sup>

## **5.5 Final Provisions**

5.5.1 This Rector's Directive entered into force on the date of its approval by the UP Scientific Board with effect from June 13, 2023.

If a modification proposal is not accepted, the Vice-Rector for Science, Arts, Sport, and Accreditation is obliged to communicate the reason for the rejection to the proposer.
