- Implementation of methodologies: PNF, Sister Kenny's method, Bobath's methodology, spinal exercises, exercises according to Kaltenborn, Becker, Klapp, Schrott, Freeman, Brunkow, balance disorders exercises, mobilization techniques.

- Implementation of basic physiotherapy methods and examinations under the supervision of a lecturer in individual departments.
