Instructions for authors

- *Annales Scientia Politica* is issued semi-annually.
- Deadlines for authors are: 31st March and 31st October.
- We welcome papers in Slovak, Czech, Polish, Ukrainian, Russian and English language.
- All submitted papers are referred through a double-blind peer-review process.
- The editorial board reserves the right to decide on publishing a paper in particular number and section.
- The authors are responsible for the factual side of the paper. The authors also guarantee that no substantial portion of the paper has been published or is under consideration for publication elsewhere and that its submission for publication has been approved by all of the authors and by the institution where the work was carried out.
- Authors submitting a paper do so on the understanding that if the paper is accepted for publication, copyright for the study or article, including the right to reproduce the study or article in all forms and media, shall be assigned exclusively to the Publisher.
- Contributions are not remunerated.
- Papers shall be sent to the address: asp@unipo.sk
- The scope of a study may not exceed 25 pages (at 1.800 characters per page), the scope of an article may not exceed 12 pages (at 1.800 characters per page).
- Footnotes shall be written in order and continuously numbered.
- Please, provide the papers with an abstract written in English (in the range of 5 – 8 lines) and 4 – 6 key words in English as well.
- Papers shall be prepared in MS Word format.
- It is required to use the citation method of the first item and date – the first entry (author's surname or the first word of the title), year of publication and numbers of cited pages appear in brackets in the text. For example (Sartori, 1993, p. 7). If there are two or more cited documents with the same first entry and the same year, they shall be distinguished by lowercase a, b, c ... inserted after the year. For example (Sartori, 1993a, p. 7).
- Bibliographical references are listed in alphabetical order by first item.
- When modifying substance or form of papers, we recommend following the articles published in the current issue of the ASP journal
- Document margins are set for – 2.5 cm, header and footer – 1.25 cm
- The font used – Times New Roman, size – 12, spacing – simple space line, text alignment – align to the block (Ctrl+J), the indentation of first line (“Tab”) – 0.5 cm, do not separate sections with free lines.
- Do not use in the text:
 - s e p a r a t i o n of letters with a spacebar
 - di-vision of words
 - underline of words (CTRL+U) and highlighting of words by using **Bold** (CTRL+B)
 - alignment to the right
 - CAPS LOCK
 - two-columns texts
 - differentiate between a letter “O” and a number “0”, a small letter “l” and a number “1”
 - do not assign styles to a paragraph, do not insert the alignment of line, section or page
