Conceptosphere of language - ethnocultural content of the word. Lexeme in ethnocultural associations and connotations. Base concepts in Russian (Ukrainian, Polish) culture. Their comparison with analogous Slovak concepts. Associative experiment as an objectifying cognitive means of ethnoculture. Choice of objective stimuli for associative experiment. Reactions in associative experiments. Hierarchization of reactions. Russian-Slovak (Ukrainian-Slovak, Polish-Slovak) differences in basic ethnocultural associations. Precedent phenomena - model ethnocultural socio-communicative units. Classification of precedent phenomena. Precedent names as a base axiological source of ethnoculture. Precedent texts and their specification in a particular ethnocultural environment. Precedent expressions and their classification. Precedent situations and their sources. Russian-Slovak (Ukrainian-Slovak, Polish-Slovak) analogies in the study of precedent phenomena. Linguistic image of the world as a cognitive base. Objective and subjective image of the world. Specific starting points of the linguistic image of Russia (Ukraine, Poland) in Slovakia.
