Learning outcomes:	
The course is focused on analysing the basic features of individual political systems and forms of government in the world. One of the main areas is the analysis of electoral systems, through which students will be introduced to the impact of electoral techniques on the nature of democracy. In addition, the course will provide students with an insight into various variants of modern political systems. Emphasis is placed on analysing ideological and political starting points that have influenced the diversity of power models and the study of the general laws of individual variants of political systems and their peculiarities.	
For completion of the course, it is necessary to meet the following conditions:	
1) Compulsory completion of continuous evaluations (two written tests); test scores must be better than FX.	
2) Active participation in lectures and seminars with the elaboration of a terminological board. This category includes regular participation, readiness for seminars, and quality of assigned tasks.

Learning outcomes: The course aims to acquaint students with the basics of comparative political science as a scientific subdiscipline, its methodological starting points and specifics. Individual lectures teach students the development and current functioning of political systems in selected countries, focusing on the Westminster model of the United Kingdom and the political systems of selected Commonwealth countries (Canada, Australia). Through the comparative method, students will gain an overview of the differences and similarities of political systems of individual countries, including a summary of political institutions, their actual functioning in political and constitutional practice and their interrelationships. Attention is focused mainly on the mutual relations between the legislative, executive and judicial powers. Within the analysis of specific political systems of states, attention is also focused on the interconnection of the electoral and party systems in connection with historical developments. The practical contribution of the course: Students will use the knowledge within their professional profile as potential employees of state administration and self-government bodies, journalists, analysts, or employees of the non-governmental sector.
