Competencies: <ul style="list-style-type: none"> - Think critically and make independent and autonomous decisions; - work and collaborate in a team and build their identity as a dental hygienist, - articulate and implement knowledge in order to develop relationships with other members of the dental team in providing patient care, - integrate general knowledge when communicating with the cariology patient. 	
Course content: <i>Conservative dentistry, client examination, caries formation and progression, division of caries cavities, conservative treatment of caries, problems of aesthetics of fillings, abrasions, erosions of hard tooth tissues, sensitive tooth cavities, causes and treatment. Endodontics, pain as a symptom, differential diagnosis, inflammation of the pulp, causes, symptoms, treatment, methods of treatment of dental canals, granuloma and</i>	

inflammation of the dentition.
