- To master the theoretical and methodological basis of the confrontational grammar of Slavic languages on the theoretical level.
- To characterize the research methods of this modern linguistic discipline: description, confrontational method, contrastive method, synchronic analysis, synchronic diachronic analysis.

- Interpret and analyze the linguistic text from the point of view of the general-linguistic, slovak-speaking, confrontational Slovak-Rusyn, Polish-Rusyn, Ukrainian-Rusyn and Synchronic.
- Abstraction from the interpreted text of the common and distinct features of literary Slovak and Rusyn, literary normative Rusyn and Polish language, literary Rusyn and Ukrainian language.
- Apply the theoretical knowledge gained on the analysis of the Slovak and Rusyn, Polish and Ukrainian texts.
- Based on the acquired theoretical knowledge to know how to work with the Rusyn literary text in the study of differential phenomena and in describing the linguistic system of the literary Rusyn language from a confrontational point of view.

- Overview of the most important linguistic dictionaries in the Slovak, Rusyn, Ukrainian and Polish languages.
- Law of the National Council of the Slovak Republic about the state language of the Slovak Republic. Law of the Use of Languages of National Minorities. Central Language Council, advisory organ to the Minister of Culture in the field of state language.
- Corpus linguistics and the use of the Slovak National Corpus for studying literary Slovak language (the Polish National Corpus for the Study of Polish, the Ukrainian National Corpus and for the Study of Ukrainian Literature).
